# FIRST AMENDMENT OF THE AGREEMENT FOR CUSTODIAL SERVICES FOR FACILITIES OUTSIDE LEE COUNTY

THIS FIRST AMENDMENT OF THE AGREEMENT FOR CUSTODIAL SERVICES FOR FACILITIES OUTSIDE LEE COUNTY is made and entered into by and between the Lee County Board of County Commissioners, a political subdivision of the State of Florida ("County") and Klen Space Inc. ("Vendor"), collectively, the "Parties."

WHEREAS, the County entered into an Agreement for the purchase of custodial services for Lee County downtown buildings through Solicitation No. RFP230052SML with Vendor on the 13<sup>th</sup> day of April, 2023 ("Agreement"); and,

WHEREAS, after the execution of the agreement, the County determined it would be in their best interest to increase the frequency of cleaning services at the Solid Waste - LaBelle Transfer Station Scale House and Solid Waste - Clewiston Transfer Station Scale House service locations by adding weekly cleaning services and expanding the monthly cleaning services being provided; and,

WHEREAS, the Parties mutually agree to supplement the Exhibit A. SCOPE OF WORK section of the Agreement and modify the pricing in the Exhibit B. FEE SCHEDULE to add weekly cleaning services and expand the monthly cleaning services being provided; and,

WHEREAS, the Parties desire to modify the Agreement pursuant to Article XV. MISCELLANEOUS of the Agreement.

NOW, THEREFORE, IN CONSIDERATION OF THE FOREGOING AND THE MUTUAL COVENANTS CONTAINED HEREIN, IT IS AGREED AS FOLLOWS:

1. The Parties agree that, effective immediately upon full execution of this Amendment, the following location and services shall supersede Subsection B. SOLID WASTE-LABELLE TRANSFER SCALE HOUSE and Subsection C. SOLID WASTE-CLEWISTON TRANSFER SCALE HOUSE, of Section 17 LOCATIONS of the Exhibit A. SCOPE OF WORK section of the agreement:

#### **SEMI ANNUAL SERVICE**

- Strip VCT floors and wax (coordinate with County SW-Facility Coordinator to move furniture items off floors)
- After deep clean items above, schedule meeting with County SW-Facility Coordinator to walk thru building for inspection.

## **Reimbursement of Consumables**

The Vendor shall be reimbursed by the County at Vendor's cost for consumable supplies. To be eligible for reimbursement for consumables purchased, the Vendor shall provide the County with sufficient documentation with respect to materials purchased and used for County facilities in a form acceptable to the County, as determined by the Director of Procurement Management. Such documentation shall provide proof of payment and the unit prices for the consumables purchased. Vendor invoices for consumables must contain at a minimum a description of the materials purchased, the quantity delivered to the facility and unit cost associated with each item.
