THIS SECOND AMENDMENT OF THE AGREEMENT FOR CUSTODIAL SERVICES FOR FACILITIES OUTSIDE LEE COUNTY is made and entered into by and between the Lee County Board of County Commissioners, a political subdivision of the State of Florida ("County") and Clean Space, LLC ("Vendor"), collectively, the "Parties."

WHEREAS, the County entered into an Agreement for the purchase of custodial services for facilities located outside of Le County through Solicitation No. RFP230052SML with Vendor on the 7<sup>th</sup> day of April, 2023 ("Agreement"); and,

WHEREAS, on the date the Agreement was executed, the Vendor's business entity name was Clean Space, Inc., with a Federal Tax ID Number of 32-0338631; and,

WHEREAS, after execution of the Agreement, the Vendor restructured as and began operating as Clean Space, LLC, with the same Federal Tax ID Number of 32-0338631; and,

WHEREAS, County and Vendor desire to enter into this Second Amendment to continue their Agreement via Solicitation No. RFP230052SML under the Vendor's new business name.

NOW, THEREFORE, IN CONSIDERATION OF THE FOREGOING AND THE MUTUAL COVENANTS CONTAINED HEREIN, IT IS AGREED AS FOLLOWS:


