TITLE: Award Contracts for Emergency Shelter Staffing Vendors

### I. MOTION REQUESTED

A) Award Request for Proposal No. RFP230083BJB, Shelter Staffing – Emergency and Disaster to Family Endeavors, Inc. (as primary) and SLSCO LTD. (as secondary) for emergency shelter staffing services, on an as needed basis, for an initial term of three years, as approved in the departments' annual adopted budget. Individual activations in excess of \$100,000.00 will be presented to the Board for approval.

- B) Authorize the Chair to execute the contract documents on behalf of the Board of County Commissioners.
- C) Grant the County Manager or designee the authority to renew the contracts, for up to three additional years, and to execute all associated documents, as approved in the departments' annual adopted budgets, if doing so is in the best interest of Lee County, and there are no cost increases associated with the renewal(s). In the event this contract is used for purposes eligible for federal reimbursement, the solicitation and contract comply with federal reimbursement regulations.

## II. ITEM SUMMARY

Approves a contract with Family Endeavors, Inc. as the primary vendor, and SLSCO LTD. as the secondary vendor for emergency shelter staffing services. In the event of an emergency, Lee County may choose to open evacuation shelters for the general public. Under this contract, at the request of the County, the vendor will provide staff to operate shelters for the general public. The contract has been solicited in accordance with all necessary rules and regulations to allow for Federal Emergency Management Agency (FEMA) reimbursement during Presidentially Declared Disasters. All costs are on an hourly basis at rates established by these agreements.

### III. BACKGROUND AND IMPLICATIONS OF ACTION

## A) Board Action and Other History

Lee County currently maintains an inventory of 21 shelter locations in coordination with the Lee County School District, FGCU, and Hertz Arena, that can be activated in the event of an emergency. During Hurricane Irma, Lee County opened 14 general population shelters, and during Hurricane Ian, Lee County opened 16 general population shelters. The County has previously staffed these shelters with County employees activated through the emergency role program to serve as shelter staff alongside staff from the Lee County School District, FGCU, and Hertz Arena.

These contract vendors would provide dedicated and trained personnel to staff the general population shelters in partnership with the County. The solicitation of a vendor to provide dedicated shelter staffing would allow some County employees to be released from their shelter staffing role to be reassigned to assist in other capacities during and after a disaster.

The contract follows all rules and regulations as required by the Federal Emergency Management Agency (FEMA) to allow for Public Assistance reimbursement in the event that the contract is activated as a result of a Presidentially Declared Disaster.
