FIRST AMENDMENT OF AGREEMENT FOR CDBG-DR INDIVIDUAL HOUSING PROGRAMS MANAGEMENT AND IMPLEMENTATION

THIS FIRST AMENDMENT OF THE AGREEMENT FOR CDBG-DR INDIVIDUAL

HOUSING PROGRAMS MANAGEMENT AND IMPLEMENTATION is made and entered into

by and between the Lee County Board of County Commissioners, a political subdivision of the

State of Florida ("County") and Horne LLP, a Delaware limited liability partnership authorized to

do business in the State of Florida, whose address is 661 Sunnybrook Rd., Suite 100 Ridgeland,

MS 39157, and whose federal tax identification number is 201941244, hereinafter referred to as

"Vendor."

WHEREAS, the County entered into Contract Number 9911 through Solicitation No.

RFP230432BAG with Vendor with an effective date of the 1st day of October 2023,

("Agreement"); and

WHEREAS, the Agreement states that work provided thereunder is funded in whole or in

part by Community Development Block Grant Disaster Recovery (CDBG-DR) funding through

the U.S. Department of Housing and Urban Development, and that the Vendor shall provide

services in support of the County's CDBG-DR Action Plan in accordance with all applicable

federal, state, and County regulations; and

WHEREAS, at the time the Agreement was executed, the County's direct CDBG-DR

allocation was designated as a result of Hurricane Ian, and required the Vendor's compliance with

the applicable Federal Register, specifically Federal Register 88 FR 32046 published May 18,

2023, and;

WHEREAS, Lee County was awarded a subsequent direct allocation of CDBG-DR

funding from the Department of Housing and Urban Development, in the amount of \$100,683,000,

for FEMA Disaster Numbers 4828 (Hurricane Helene) and 4834 (Hurricane Milton) according to

the Allocation Announcement Notice (AAN) 90 FR 4759 and the Universal Notice 90 FR 1754

with terms pending acceptance of the funds by the Board of County Commissioners; and

WHEREAS, the Application and Activity Performance Sections 3.10.2.1.3.2.6 and 3.10.2.2.4.2.4 of the Agreement provide, in part, that the Vendor may complete environmental

reviews in collaboration with the County's Staff Augmentation Vendor; and

WHEREAS, the County requires the Vendor's assistance with Broad-Level Tier 1

Environmental Reviews, and the parties negotiated a flat rate fee for such services; and

WHEREAS, the County desires to amend the language in the Agreement pursuant to

Section XVI, Miscellaneous, to provide for streamlined processes that best align with the

administration of the individual housing program by the Vendor, ensure compliance with

applicable regulations, and add fees for services necessary to carry out the County's CDBG-DR

programs.

NOW, THEREFORE, IN CONSIDERATION OF THE FOREGOING AND THE MUTUAL

COVENANTS CONTAINED HEREIN, IT IS AGREED AS FOLLOWS:

1. The Vendor shall conduct its work under the Agreement in full compliance with all

applicable federal, state, and County regulations for the CDBG-DR allocation under which

the work is assigned, including the appropriate Federal Register without the need of an

amendment to the Agreement. All future Task Orders shall identify the FEMA Disaster

Number that applies to the assignment.

2. Exhibit C Fee Schedule is amended to include Broad-Level Tier 1 Environmental Review

at the Flat Rate price of \$17,500.

3. Reimbursements for the administration of the individual housing program detailed in the

Agreement will be made in compliance with the applicable policies and procedures

governing the CDBG-DR allocations funding the work under this Agreement.

4. Sections 3.10.2.1.3.2.6 and 3.10.2.2.4.2.4 of the Detailed Specifications Section of Exhibit

F incorporated into the Agreement shall be superseded in their entirety by the following:

"Ensure the completion of appropriate levels of environmental reviews for each activity.

The vendor shall document each case file and the HUD Environmental Review Online

System (HEROS) as necessary to ensure compliance with 24 CFR Part 58."
