

SECOND AMENDMENT OF AGREEMENT FOR CDBG-DR INDIVIDUAL HOUSING PROGRAMS MANAGEMENT AND IMPLEMENTATION

THIS SECOND AMENDMENT OF THE AGREEMENT FOR CDBG-DR INDIVIDUAL HOUSING PROGRAMS MANAGEMENT AND IMPLEMENTATION is made and entered into by and between the Lee County Board of County Commissioners, a political subdivision of the State of Florida ("County") and BDO Government Services, LLC, a Delaware corporation authorized to do business in the State of Florida, whose address is 1201 Hays Street, Tallahassee, FL 32301, and whose federal tax identification number is 39-3226184, hereinafter referred to as "Vendor."

WHEREAS, the County entered into Contract Number 9911 through Solicitation No. RFP230432BAG with Vendor with an effective date of the 1st day of October 2023, ("Agreement"); and

WHEREAS, the Agreement states that work provided thereunder is funded in whole or in part by Community Development Block Grant Disaster Recovery (CDBG-DR) funding through the U.S. Department of Housing and Urban Development, and that the Vendor shall provide services in support of the County's CDBG-DR Action Plan in accordance with all applicable federal, state, and County regulations; and

WHEREAS, Horne, LLP, was acquired by BDO USA and effective November 1, 2025, Horne, LLP will now be operating as BDO Government Services, LLC and;

WHEREAS, all parties recognize that future task orders awarded to Horne, LLP will be executed as BDO Government Services, LLC and payments, effective January 1, 2026, will be remit to BDO Government Services, LLC.

NOW, THEREFORE, IN CONSIDERATION OF THE FOREGOING AND THE MUTUAL COVENANTS CONTAINED HEREIN, IT IS AGREED AS FOLLOWS:

1. The Vendor shall conduct its work under the Agreement in full compliance with all applicable federal, state, and County regulations for the CDBG-DR allocation under which the work is assigned.
2. Horne LLP, a Delaware limited liability partnership previously authorized to do business

in the State of Florida, whose address is 661 Sunnybrook Rd., Suite 100, Ridgeland, MS 39157, and whose federal tax identification number is 201941244 will heretofore be known as BDO Government Services, LLC, a Delaware corporation authorized to do business in the State of Florida, whose address is 1201 Hays Street, Tallahassee, FL 32301, and whose federal tax identification number is 39-3226184.

Except as expressly set forth herein, all of the terms, covenants and conditions of the Agreement are hereby ratified and confirmed, and each party, by the execution of this Second Amendment of the Agreement hereby signifies their intent to be bound thereby.
