2.	Is it Lee County's intention to include actuarial analysis or other extensive financial modeling in this scope of work?
Answer	Actuarial analysis or financial modeling may be incorporated into the scope of work to assess the costs and benefits of the continuum of care model, identify potential cost savings, or determine the financial feasibility of implementing the model. Such analysis would be based on the needs and resources of Lee County, as well as the specific requirements of the behavioral health system being developed.
3.	Does Lee County intend to award all of the \$1 million allocated to this initiative as stated in the 2023 Action Plan CDBG-DR? If not, what is the proposed budget for this initiative?
Answer	All CDBG-DR related expenditures must be considered fair and reasonable. Although the County has budgeted the full \$1 million to this initiative in the event that it is needed, proposers are reminded that proposals should be competitively priced and will be scored accordingly. Answer	18-month is the maximum time frame for final completion. Tab 3:Plan of Approach shall define the milestones and deliverables.

6.	Is Lee County coordinating with the Agency for Health Care Administration and/or Department of Children and Families Office of Substance Abuse and Mental Health on this work? What expectations does the County have for the consultant related to considering Medicaid and state funding streams for long term sustainability?
Answer	Please refer to solicitation documents page 33, article 2.2.1.5 Financial and Regulatory Consideration, as well as page 34, section 2.3.1.5. which states: 2.3.1.5. Develop a ten (10) year comprehensive funding sustainability plan including Federal, State, and local funding sources.Lee County expects the consultant to thoroughly analyze and evaluate these funding streams. The consultant shall identify opportunities to leverage Medicaid and state funding to support the sustainability of the initiative beyond the initial funding period. This shall include developing strategies to maximize reimbursement, accessing additional funding sources, and ensuring compliance with Medicaid and state requirements.
