FOURTH AMENDMENT OF THE AGREEMENT FOR CUSTODIAL FOR DOWNTOWN BUILDINGS

THIS FOURTH AMENDMENT OF THE AGREEMENT FOR CUSTODIAL FOR

DOWNTOWN BUILDINGS is made and entered into by and between the Lee County Board of

County Commissioners, a political subdivision of the State of Florida ("County") and United

States Service Industries, Inc. dba Grupo Eulen ("Vendor"), collectively, the "Parties."

WHEREAS, the County entered into an Agreement for the purchase of custodial services

for Lee County downtown buildings through Solicitation No. RFP240120SML with Vendor on

the 19th day of November, 2024 ("Agreement"); and,

WHEREAS, after the execution of the agreement, the County agreed to have Greyhound

Bus Service return to the Rosa Parks Intermodal Facility, which will increase the amount of daily

traffic in that facility; and,

WHEREAS, as a result of the increase in traffic the County determined that it was

necessary to increase the frequency of daily custodial services being provided for the Rosa Parks

Intermodal Facility custodial service location, located at 2250 Widman Way; and,

WHEREAS, as a result of the increase in traffic it was also determined that the quarterly

cleaning service provided for the Rosa Parks Intermodal Facility would be more involved than

originally anticipated, and therefore an increase in cost is anticipated; and,

WHEREAS, the Parties mutually agree to supplement the Exhibit A. Detailed

Specifications section of the Agreement and modify the pricing in the Exhibit B. Fee Schedule to

increase the frequency of daily cleanings from cleaning 3 times per day, 6 days per week to 4 times

per day, 7 days per week and increase the cost for the quarterly service being provided for the Rosa

Parks Intermodal Facility custodial service location; and,

WHEREAS, the Parties desire to modify the Agreement pursuant to Article XVI.

NOW, THEREFORE, IN CONSIDERATION OF THE FOREGOING AND THE MUTUAL

COVENANTS CONTAINED HEREIN, IT IS AGREED AS FOLLOWS:

Scheduling

- a. Lee County, working with the Vendor, may designate the time during which selected areas shall be cleaned.
- b. Cleaning shall be performed on a seven days per week basis, **inclusive** of holidays (LeeTran operates on a more limited holiday schedule than Lee County as a whole.
- c. Vendor will be given a minimum of 48 hours' notice of any schedule change.
- d. Each bathroom must be cleaned, sanitized, mopped, toilet tissue replenished, soap dispenser replenished, trash removed and new trash can liner installed. Bathrooms must be cleaned three times per day. Both sides of the bathroom doors must be wiped down with a disinfectant during each cleaning.

Service Identifiers to be performed at this location as listed above:

- Daily Services
- Weekly Services
- Monthly Services
- Quarterly Services
- Semiannual Services
- Unique Services to be provided
 - Vacuuming of offices is to be done twice a week (Monday and Thursday) and all remaining carpet in walkways and common areas is to be vacuumed every day.

- e. Vendor shall complete the following task on the exterior of the building daily:
 - Pick-up trash around building and canopies.
 - Empty and put in new liner bag in trash cans around building and canopy areas
 - Sweep and power wash steps and external flooring once a week and more often as required. Shake and sweep down interior/exterior floor mats.
 - Building exterior window washing once monthly as required.
 - Wipe down the LeeTran ticket Vendor machines
 - Additional items listed above under daily services
- f. Vendor shall complete the following tasks for the interior of the building daily, inclusive of the office space:
 - Empty all wastebaskets.
 - Sweep and mop floor in the office space.
 - Clean and sanitize drinking fountains.
 - Clean walls and windows.
 - Sweep floor mats.
 - Wipe down vending machines
 - Additional items listed above under daily services

Fee Schedule of the Agreement will be increased by \$5,039.20 per year, for the initial contract term, \$5,621.76 per year, for Optional Renewal #1 – Year Four, and \$5,901.36 per year, for Optional Renewal #2 – Year Five for the increased cleanings to the Rosa Parks Intermodal Facility custodial service location and the Exhibit B.
