The following represents clarification, additions, deletions, and/or modifications to the above referenced bid. This addendum shall hereafter be regarded as part of the solicitation. Items not referenced herein remain unchanged, including the response date. Words, phrases or sentences with a strikethrough represent deletions to the original solicitation. Underlined words and bolded, phrases or sentences represent additions to the original solicitation.

1. REVISED PRICE PROPOSAL FORM

The price proposal form has been updated to incorporate the pricing of the Special Projects Cost Schedule, identified as Appendix 15. This can be located in Worksheet # 2 within the revised price proposal form. The Special Projects Cost Schedule pricing (Worksheet #2) being provided by Proposers will not be considered as part of the Financial Proposal Scoring Procedures as detailed in the evaluation criteria, Tab 5. However, the Special Projects Cost Schedule pricing will be reviewed and incorporated into the draft agreement during negotiations of the service agreement. The updated **Addendum 5 Revised Price Proposal Form** has been uploaded to the solicitation webpage on the Lee County Procurement website.

Please ensure that your firm has downloaded the **Addendum 5 Revised Price Proposal Form** and are able to successfully use the Excel format. Any firm having compatibility issues or difficulty downloading the Revised Price Proposal Form needs to contact the Procurement Analyst for this project at their earliest convenience. Do not wait until submission day to download. Procurement is not required to extend a closing due to Contractor delay or difficulty in receipt of download of documents.

Proposers **MUST** use the **Addendum 5 Revised Price Proposal Form** when submitting their proposal. The County will not accept pricing proposals submitted on forms or in formats other than the **Addendum 5 Revised Price Proposal Form**, as provided by the County. Proposals submitted on forms, other than the **Addendum 5 Revised Price Proposal Form**, will deem Proposers as non-responsive and ineligible for award.

Proposers shall not adjust or modify any amounts or County authorized data provided within the pricing proposal form. Proposals received with modified data or quantities may deem the Proposer as non-responsive and ineligible for award.

2. REVISIONS

The following shall be considered revised to the draft agreement as provided with this solicitation:

SECTION 2.6 – REGULATORY REQUIREMENTS

Section I

All construction-related Cost-Substantiated Special Projects, including repairs, must be procured in accordance with Lee County Ordinance No. 22-06 **and 23-21** requirements, or be performed by the Company in accordance with the Cost Schedule in Appendix 15. **The Cost Schedule in Appendix 15 shall only be used for projects under \$50,000.00**

4. QUESTIONS/ANSWERS

1.	I would like to have a copy of the previously awarded bidder documents. If you are unable to locate it would I be able to have the incumbent vendors current pricing for line items billed to Lee County pertaining to the Landfill Operating Agreement.
Answer	The current contract with the incumbent vendor is over 30+ years old. Unfortunately, the County is unable to locate a copy of the awarded bidders submittal because of the amount of years that have passed. However, the County is providing a copy of the current agreement with the incumbent vendor. See attachment # 2 to this addendum. Please note that because of the way the pricing is structured and the additional fees that are paid to and charged to the vendor, actual dollar amounts are not present within the agreement. The County has provided a 5 year invoice history of payments made to the current incumbent vendor. Proposers are encouraged to review this document to obtain the numbers you seek with regards to pricing and line items billed. The 5 year invoice history document is identified as attachment # 3 to the original solicitation.
