TITLE: Award Contract for Employee Disability Benefits

### I. MOTION REQUESTED

- A. Award Request for Proposal No. RFP250137JLO, Employee Benefits Disability Benefits to Standard Insurance Company to provide a fully insured group disability plan, offering long-term and short-term disability benefits for County employees and participating entities, on an as-needed basis, for an initial term of three years, as approved in the departments' annual adopted budget.
- B. Authorize the Chair to execute the contract documents on behalf of the Board of County Commissioners.
- C. Grant the County Manager or designee the authority to renew the contract, for up to two additional years, and to execute all associated documents, as approved in the departments' annual adopted budgets, if doing so is in the best interest of Lee County.

#### II. ITEM SUMMARY

Awards a three-year contract to Standard Insurance Company to provide and administer employee long-term and short-term disability benefits, with two possible renewals. Long-term coverage is employer-paid, short-term is voluntary employee-paid, with a three-year rate guarantee. Long-term disability costs were approximately \$702,056 in FY24–25 and are projected at \$548,597 in FY25–26, saving \$153,459. Short-term voluntary coverage is estimated at \$369,759.

### III. BACKGROUND AND IMPLICATIONS OF ACTION

Procurement Management issued Request for Proposal No. RFP250137JLO Employee Benefits – Disability Benefits. On the solicitation deadline of June 11, 2025, Procurement Management received seven (7) submittals.

An evaluation meeting was held on July 28, 2025, during which the Evaluation Committee considered criteria as listed in the solicitation request, including such items as: Experience & Reference, Customer Service, Claim Processing, Performance Metrics & Guarantees, Plan Design, Cost Consideration & Contractual Terms, Systems Reporting, and Local Vendor Preference.

Based on the information submitted by the proposers, the Committee reached a consensus to negotiate with and recommend the award of a contract to Standard Insurance Company for use on an as-needed basis for an initial three-year term. The contract can be renewed up to two additional years, upon the agreement of both parties.
