THIRD AMENDMENT TO THE AGREEMENT FOR RECYCLING & SOLID WASTE ADVERTISING & MARKETING SERVICES

THIS THIRD AMENDMENT OF THE AGREEMENT FOR RECYCLING & SOLID WASTE ADVERTISING & MARKETING SERVICES, is made by and between the Lee County Board of County Commissioners, a political subdivision of the State of Florida ("County") and Z Axis Solutions LLC ("Vendor"), collectively, the "Parties."

WHEREAS, the County entered into an Agreement for the purchase of advertising and marketing services, through Solicitation RFP220204DWJ, with Vendor on the 22nd day of October, 2022 ("Agreement"); and,

WHEREAS, Section 1.2 of the Exhibit B. Fee Schedule provides that "Fees provided for within the final Agreement shall be renegotiated annually and shall be replaced in its entirety by an amendment to the Agreement executed by the County and the Vendor;" and,

WHEREAS, the Parties desire to modify the Exhibit B. Fee Schedule, pursuant to Article XIV. Miscellaneous of the Agreement, to set forth the Project Fees for year 2 of the Agreement.

NOW, THEREFORE, IN CONSIDERATION OF THE FOREGOING AND THE MUTUAL COVENANTS CONTAINED HEREIN, IT IS AGREED AS FOLLOWS:

1. The Parties agree that Exhibit B. Fee Schedule for the Vendor shall be superseded by the following:

1. Compensation

- 1.1. For all services and work products described in Exhibit A, the County agrees to pay the Vendor as provided below for the second year of the Agreement. Total payments under this Agreement for the second year shall not exceed \$125,000.00; however, the fee allocated to each Task below may be adjusted by the County in order to best take advantage of current market conditions.
- 1.2. Fees provided for within the final Agreement shall be renegotiated annually and shall be replaced in its entirety by an amendment to the Agreement executed by the County and the Vendor.
