

FIRST AMENDMENT OF THE AGREEMENT FOR SUPPLY OF ROCK, AGGREGATE,  
SCREENINGS, SAND, AND OTHER RELATED MATERIALS – ANNUAL

THIS FIRST AMENDMENT OF THE AGREEMENT FOR SUPPLY OF ROCK,  
AGGREGATE, SCREENINGS, SAND, AND OTHER RELATED MATERIALS – ANNUAL  
is made and entered into by and between the Lee County Board of County Commissioners, a  
political subdivision of the State of Florida ("County") and Gripco Pavement Maintenance Inc.  
("Vendor"), collectively, the "Parties."

WHEREAS, the County entered into an Agreement to purchase rock, aggregate, base  
material, sand, rip rap, and other related materials through Solicitation No. B200048ANB with  
Vendor on the 11<sup>th</sup> day of September, 2020 ("Agreement "); and,

WHEREAS, the Parties mutually agree to increase the price for rock, aggregate, base  
material, sand, rip rap, and other related materials from the Vendor; and,

WHEREAS, the Parties mutually agree that the price increase will begin on the 25<sup>th</sup> day of  
August, 2021; and,

WHEREAS, the Vendor is now the only remaining vendor on the agreement; and,

WHEREAS, the Vendor will now be providing services for all categories and materials;  
and,

WHEREAS, the Parties desire to modify the Agreement pursuant to Article XV.  
MISCELLANEOUS of the Agreement.

NOW, THEREFORE, IN CONSIDERATION OF THE FOREGOING AND THE MUTUAL  
COVENANTS CONTAINED HEREIN, IT IS AGREED AS FOLLOWS:

1. The Parties agree that the price increase will begin on the 25<sup>th</sup> day of August, 2021.
2. The Vendor is now the sole vendor, for all categories and materials.
3. The Parties agree that the following Fee Schedule shall supersede the existing Fee  
Schedule in Exhibit B of the Agreement:
