On September 3, 2020, Lee County entered into an Agreement with Green Dream International, LLC for the purchase of rock, aggregate, base material, sand, rip rap, and other related materials, on an as needed basis. Lee County has made the decision to discontinue the Agreement with Green Dream.

Pursuant to Section XII. Termination, of the Agreement for Supply of Rock, Aggregate, Screenings, Sand, and Other Related Materials, the County is exercising its right to terminate the Agreement for convenience. In compliance with the termination procedures established by Section XII, the Agreement shall terminate as of April 11, 2021. Commencing upon the date of receipt of this Notice, the County is mandating a suspension of any remaining work under the Agreement.

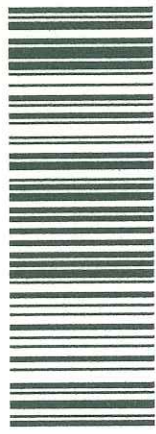
