This site visit is not a public meeting. There will be no County staff present for the purpose of discussing the project or answering questions. All questions derived from this site visit should be submitted in an email to the procurement analyst assigned to this project. This is a “window of opportunity” for potential bidders to obtain access for additional viewing of the site. The location of the site visit is in a secure area. The time frame provided is the allocated time slot for access to the roof. There will be no opportunity for potential bidders to stop in and request additional viewing or investigations after the date and time slot have passed. Potential bidders who attempt to do so will be turned away.

Only Vendors who participated in the original Mandatory Pre-Bid meeting on March 14, 2023, will be allowed access to the roof for additional viewing.

Vendors who attended the original Mandatory Pre-Bid meeting on March 14, 2023 are not required to attend this additional site visit.
