THIS FIRST AMENDMENT OF THE AGREEMENT FOR SODIUM CHLORIDE (SALT) - ANNUAL is made and entered into by and between the Lee County Board of County Commissioners, a political subdivision of the State of Florida ("County") and Odyssey Manufacturing CO. ("Vendor"), collectively, the "Parties."

WHEREAS, the County entered into an Agreement to purchase high-grade bulk salt (Sodium Chloride) from the Vendor through Solicitation No. B210188DWJ with Vendor on the 9th day of August 2021 ("Agreement "); and,

WHEREAS, the Parties mutually agree to increase the price for the purchase of Sodium Chloride from the Vendor; and,

WHEREAS, the Parties mutually agree that the price increase will begin on the 3rd day of August, 2024; and,

WHEREAS, the Parties desire to modify the Agreement pursuant to Article XV. MISCELLANEOUS of the Agreement.

NOW, THEREFORE, IN CONSIDERATION OF THE FOREGOING AND THE MUTUAL COVENANTS CONTAINED HEREIN, IT IS AGREED AS FOLLOWS:

1. The Parties agree that the price increase will begin on the 3rd day of August 2024.
2. The Parties agree that the following Fee Schedule shall supersede the existing Fee Schedule in Exhibit B of the Agreement:
