Approve Contract Renewal and Amendment for Sodium Chloride

MOTION REQUESTED I.

A) Approve Amendment No. 1 to the contract with Odyssey Manufacturing Co., under Solicitation No. B210188DWJ Sodium Chloride (Salt), to increase the price of Sodium Chloride to \$209.82 per dry ton. The amendment will increase the contract amount by approximately \$72,036.00 annually.

B) Approve contract renewal for the purchase and delivery of Sodium Chloride, from Odyssey Manufacturing Co., under Solicitation No. B210188DWJ, through August 2, 2025.

C) Authorize the County Manager or designee to execute the amendment on behalf of the Board of County Commissioners.

II. **ITEM SUMMARY**

Approves an amendment to the annual contract with Odyssey Manufacturing Co., to increase the cost of Sodium Chloride. The vendor submitted the required documentation to Procurement Management to renew the contract for an additional one-year period and increase the price to \$209.82 per ton, or 7.6%. The total previous twelve-month spend with Odyssey is \$947,840.40.

III. **BACKGROUND AND IMPLICATIONS OF ACTION**

A) Board Action and Other History

On August 3, 2021, the Board of County Commissioners awarded B210188DWJ Sodium Chloride (Salt), Odyssev Manufacturing Co., on an as-needed basis. The original term of the contract was for three-years with an option to renew for up to three (3) additional years. There have been no prior price increase requests from the vendor since contract award in August 2021.

Current Board approval will allow for a one-year contract renewal and price increase from \$195.00 per ton to \$209.82 per ton (or 7.6% increase).

This product is used at the Green Meadows Water Treatment Plant for the regeneration of the ion exchange treatment process to convert raw water to potable water.

The current contract for Sodium Chloride is \$195.00 per dry ton, and the new contract price is \$209.82 per dry ton, a 7.6% increase. The vendor indicated the need for a unit price increase was due to ongoing inflation which has increased with suppliers, insurance, and labor costs. This is the first price increase requested in three years and is estimated to add an additional \$72,036 annually.
