THIS FIRST AMENDMENT OF THE ANNUAL AGREEMENT FOR SODIUM HYDROXIDE 25% AND 50% (CAUSTIC SODA) - ANNUAL made and entered into by and between the Lee County Board of County Commissioners, a political subdivision of the State of Florida ("County") and Allied Universal Corp. ("Vendor"), collectively, the "Parties."

WHEREAS, the County entered into an Agreement for the purchase of sodium hydroxide (caustic soda), services through Solicitation B220047DWJ with Vendor on the 31st day of May, 2022 ("Agreement"); and,

WHEREAS, the Parties mutually agree to increase the rate for the purchase of Item # 2 Sodium Hydroxide 50% from the Vendor, to be effective the 15th day of August 2026; and,

WHEREAS, the Parties desire to modify the Agreement pursuant to Article XV. MISCELLANEOUS of the Agreement to increase the rate for the purchase of Sodium Hydroxide 50% from the Vendor.

NOW, THEREFORE, IN CONSIDERATION OF THE FOREGOING AND THE MUTUAL COVENANTS CONTAINED HEREIN, IT IS AGREED AS FOLLOWS:

1. The Parties agree that, effective the 15th day of August 2026, the following Fee Schedule table shall supersede the existing Fee Schedule table in Exhibit B of the Agreement:
