THIRD AMENDMENT OF ANNUAL AGREEMENT FOR SODIUM HYPOCHLORITE FOR WATER & WASTEWATER FACILITIES

THIS THIRD AMENDMENT OF THE ANNUAL AGREEMENT FOR SODIUM HYPOCHLORITE FOR WATER & WASTEWATER FACILITIES made and entered into by and between the Lee County Board of County Commissioners, a political subdivision of the State of Florida ("County") and Allied Universal Corp. ("Vendor"), collectively, the "Parties."

WHEREAS, the County entered into an Agreement for the purchase of sodium hypochlorite through Solicitation B200320DWJ with Vendor on the 9th day of September, 2020 ("Agreement"); and,

WHEREAS, after the execution of the Agreement it was discovered that there was some confusion between the Parties regarding the appropriate procedure for determining invoice pricing; and,

WHEREAS, the Parties desire to clarify that pricing for invoicing shall be based upon the date of product delivery, rather than the date of purchase; and,

WHEREAS, the Parties also mutually agree to increase the rate for the purchase of sodium hypochlorite from the Vendor, to be effective the 1st day of September 2023; and,

WHEREAS, the Parties desire to modify the Agreement pursuant to Article XV. MISCELLANEOUS of the Agreement to increase the rate for the purchase of sodium hypochlorite from the Vendor and to clarify invoicing procedures for the Agreement.

NOW, THEREFORE, IN CONSIDERATION OF THE FOREGOING AND THE MUTUAL COVENANTS CONTAINED HEREIN, IT IS AGREED AS FOLLOWS:

 The Parties agree that the Paragraph B of Article IV. METHOD OF PAYMENT of the Agreement shall be superseded by:

"The Vendor shall submit an invoice for payment to the County on a monthly basis for those specific products and services as described in Exhibit A (and the corresponding fees as described in Exhibit B) that were provided during that invoicing period. The pricing for products being ordered by the County shall be determined by the pricing on the date of product delivery to the County."

2. The Parties agree that the following Fee Schedule table shall supersede the existing Fee Schedule table in Exhibit B of the Agreement:
