



## **AGREEMENT FOR PIGGYBACK PURCHASE**

THIS AGREEMENT FOR PIGGYBACK PURCHASE is made and entered into by and between the Lee County Board of County Commissioners, a political subdivision of the State of Florida ("County") and NewGen Strategies and Solutions, LLC, a Colorado company authorized to do business in the State of Florida, hereinafter referred to as the "Vendor".

WHEREAS, the Vendor entered into a Services Agreement with Pinellas County, Contract Number 22-0644-P, through their Solicitation No. RFP22-0644-P, on the 11<sup>th</sup> day of April 2023 for Solid Waste and Waste Diversion Consulting Services ("Agreement"); and

WHEREAS, the Agreement is eligible for piggyback purchases; and

WHEREAS, the County desires to make purchases from the Vendor under the same terms and conditions of the Agreement.

NOW, THEREFORE, IN CONSIDERATION OF THE FOREGOING AND THE MUTUAL COVENANTS CONTAINED HEREIN, IT IS AGREED AS FOLLOWS:

The County and the Vendor agree to be bound by the terms and conditions of the Agreement with respect to the County's purchases of Solid Waste and Waste Diversion Consulting Services from the Vendor during the term of the Agreement from the effective date and any renewals or extensions thereof, except that Article 27. Applicable Law and Venue shall be superseded by: "Florida law governs this Contract. Venue for all legal proceedings out of this Contract, or its breach, must be in the appropriate state court in Lee County or federal court in Fort Myers, Florida." The effective date shall be the date the Lee County Board of County Commissioners awarded the Solicitation to the Vendor.


