FOURTH AMENDMENT OF SOLID WASTE AND RECYCLING COLLECTION FRANCHISE AGREEMENT FOR LEE COUNTY SERVICE AREA NUMBER TWO

THIS FOURTH AMENDMENT OF THE SOLID WASTE AND RECYCLING COLLECTION FRANCHISE AGREEMENT FOR LEE COUNTY SERVICE AREA NUMBER TWO, is made and entered into by and between the Lee County Board of County Commissioners, a political subdivision of the State of Florida ("County") and Waste Management Inc. of Florida ("Contractor"), collectively, the "Parties."

WHEREAS, the County entered into an Agreement for the purchase of collection and hauling services for Franchise Service Area Number Two in Lee County with Contractor on the 29th day of September, 2023 ("Agreement"); and,

WHEREAS, Section 6. CHARGES, RATES, PAYMENTS, DISPUTES, and INTEREST RATES of the Agreement permits the Contractor, with County approval, to be granted an annual rate adjustment to the Curbside Residential Solid Waste Collection Service, Commercial Solid Waste Collection Service and Curbside Residential Recycling Collection Service rates, using a Consumer Price Index ("CPI") calculation outlined in the Agreement. However, Section 6. CHARGES, RATES, PAYMENTS, DISPUTES, and INTEREST RATES does not provide for the same rate increase request for the Vegetative Storm Debris Collection Service rates in the "NOT-TO-EXCEED RATES FOR VEGETATIVE STORM DEBRIS COLLECTION SERVICE" section of the Exhibit II RATE SCHEDULE FOR FRANCHISE SERVICE AREA 2 of the Agreement; and,

WHEREAS, the parties desire to allow requests for rate increases to the Vegetative Storm Debris Collection Service rates in the "NOT-TO-EXCEED RATES FOR VEGETATIVE STORM DEBRIS COLLECTION SERVICE" section of the Exhibit II RATE SCHEDULE FOR FRANCHISE SERVICE AREA 2 of the Agreement;

WHEREAS, on August 6, 2024, the Lee County Board of County Commissioners approved a CPI franchise hauler commercial rate adjustment and a residential rate increase of 0.73% for the 2024-2025 Fiscal Year; and,

> WHEREAS, the Parties also agree to apply the 0.73% CPI increase for the 2024-2025 Fiscal Year to the "NOT-TO-EXCEED RATES FOR VEGETATIVE STORM DEBRIS COLLECTION SERVICE" section of the Exhibit II RATE SCHEDULE FOR FRANCHISE SERVICE AREA 2 of the Agreement; and,

> WHEREAS, County and Contractor desire to enter into this Fourth Amendment to memorialize the previously approved CPI increases for all of the aforementioned Curbside Residential Solid Waste Collection Service, Commercial Solid Waste Collection Service and Curbside Residential Recycling Collection Service rates for the 2024-2025 Fiscal Year in EXHIBIT II. RATE SCHEDULE FOR FRANCHISE SERVICE AREA 2, modify Section 6. CHARGES, RATES, PAYMENTS, DISPUTES, and INTEREST RATES of the Agreement to permit increase requests for the 2024-2025 Fiscal Year to the Vegetative Storm Debris Collection Service rates, and apply the same 0.73% CPI increase for the 2024-2025 Fiscal Year to the Vegetative Storm Debris Collection Service rates listed in the "NOT-TO-EXCEED RATES FOR VEGETATIVE STORM DEBRIS COLLECTION SERVICE" section of the Exhibit II RATE SCHEDULE FOR FRANCHISE SERVICE AREA 2 of the Agreement.

NOW, THEREFORE, IN CONSIDERATION OF THE FOREGOING AND THE MUTUAL COVENANTS CONTAINED HEREIN, IT IS AGREED AS FOLLOWS:

 Effective contemporaneously with the effective date of the Agreement, the first paragraph of Section A. Solid Waste and Recycling Collection Rate Adjustments of Section 6. CHARGES, RATES, PAYMENTS, DISPUTES, and INTEREST RATES of the Agreement shall be superseded by:

"For all Collection services, the charges shall be initially based on the rates established in Exhibit II, and as subsequently adjusted pursuant to this Agreement. The Contractor may receive an annual adjustment in the Curbside Residential Solid Waste Collection Service, Commercial Solid Waste Collection Service, Curbside Residential Recycling Collection Service and Vegetative Storm Debris Collection Service rates, beginning 12 months after the Start of Service Date."

- Effective October 1, 2024, the Exhibit II. RATE SCHEDULE FOR FRANCHISE SERVICE AREA 2, FY 2023-2024, of the Agreement shall be retitled: "Exhibit II. RATE SCHEDULE FOR FRANCHISE SERVICE AREA 2."
- 3. The new increased rates for Curbside Residential Solid Waste Collection Service, Commercial Solid Waste Collection Service, Curbside Residential Recycling Collection Service, and Vegetative Storm Debris Collection Service listed in the updated Exhibit II. RATE SCHEDULE FOR FRANCHISE SERVICE AREA 2 implemented by this Amendment, and included in the updated tables below, shall go into effect on October 1 for the applicable fiscal year listed in the tables.
- 4. Effective October 1, 2024, the fee table titled "Service Rates for Solid Waste Recycling Collection Franchise Agreement – Service Area 2" in the newly titled Exhibit II. RATE SCHEDULE FOR FRANCHISE SERVICE AREA 2 of the Agreement shall be superseded by:
