

FIRST AMENDMENT OF THE AGREEMENT FOR SUPPLY & DELIVERY OF SODIUM
HYPOCHLORITE FOR SWIMMING POOLS & WATER FEATURES

THIS FIRST AMENDMENT OF THE AGREEMENT FOR SUPPLY & DELIVERY
OF SODIUM HYPOCHLORITE FOR SWIMMING POOLS & WATER FEATURES is made
and entered into by and between the Lee County Board of County Commissioners, a political
subdivision of the State of Florida ("County") and Hawkins Water Treatment Group, Inc.
("Vendor"), collectively, the "Parties."

WHEREAS, the County entered into an Agreement to purchase liquid sodium hypochlorite
solution (12.5%) from the Vendor through Solicitation No. B220160WCD with Vendor on the 27th
day of June 2022 ("Agreement "); and,

WHEREAS, the Parties mutually agree to increase the price for liquid sodium hypochlorite
solution (12.5%) from the Vendor; and,

WHEREAS, the Parties mutually agree that the price increase will begin on the 21st day of
June, 2023; and,

WHEREAS, the Parties desire to modify the Agreement pursuant to Article XV.
MISCELLANEOUS of the Agreement.

NOW, THEREFORE, IN CONSIDERATION OF THE FOREGOING AND THE MUTUAL
COVENANTS CONTAINED HEREIN, IT IS AGREED AS FOLLOWS:


1. The Parties agree that the price increase will begin on the 21st day of June 2023.
2. The Parties agree that the following Fee Schedule shall supersede the existing Fee
Schedule in Exhibit B of the Agreement:
