TITLE: Approve Contract Amendment for Supply of Pit Shell

I. MOTION REQUESTED

A) Approve Amendment No.1 with Grippo Pavement Maintenance, Inc., under Solicitation No. B210042MIF, Supply of Pit Shell, to adjust pricing in Exhibit B, Fee Schedule of the agreement.

B) Approve the contract renewal for the purchase and supply of pit shell on an as-needed basis, from Grippo Pavement Maintenance, Inc., under Solicitation No. B210042MIF, for four months through September 3, 2024.

C) Authorize the County Manager or designee to execute the documents on behalf of the Board of County Commissioners.

II. ITEM SUMMARY

Approves a contract amendment with Grippo Pavement Maintenance, Inc., under the solicitation for Supply of Pit Shell, to adjust pricing in Exhibit B, resulting in an 37.08% increase in the contract amount.. Total expenditures to-date during Fiscal Year 2023/24 were \$90,884.49. Approves the contract renewal through September 3, 2024.

Approves a contract amendment with Grippo Pavement Maintenance, Inc., under the solicitation for Supply of Pit Shell, to adjust pricing in Exhibit B. Total expenditures to-date during Fiscal Year 2023/24 were \$90,884.49. Approves the contract renewal through September 3, 2024.

B) Policy Issues

On May 4, 2021, the Board of County Commissioners awarded B210042MIF Supply of Pit Shell, to Green Dream International, LLC, Grippo Pavement Maintenance, Inc., Nickale Corp., and VLK Construction Services, Inc. {to provide for the purchase and supply of pit shell on an as-needed basis. The original term of the contract was for three-years with an option to renew for up to three years.
