FIRST AMENDMENT OF THE AGREEMENT FOR SUPPLY OF PIT SHELL

THIS FIRST AMENDMENT OF THE AGREEMENT FOR SUPPLY OF PIT SHELL is made and entered into by and between the Lee County Board of County Commissioners, a political subdivision of the State of Florida ("County") and Grippo Pavement Maintenance Inc. ("Vendor"), collectively, the "Parties."

WHEREAS, the County entered into an Agreement to purchase pit shell through Solicitation No. B210042MIF with Vendor on the 12th day of May, 2021 ("Agreement"); and,

WHEREAS, the Parties mutually agree to increase the price for pit shell from the Vendor; and,

WHEREAS, the Parties mutually agree that the price increase will begin on the 4th day of May 2024; and,

WHEREAS, the Parties desire to modify the Agreement pursuant to Article XV. MISCELLANEOUS of the Agreement.

NOW, THEREFORE, IN CONSIDERATION OF THE FOREGOING AND THE MUTUAL COVENANTS CONTAINED HEREIN, IT IS AGREED AS FOLLOWS:

1. The Parties agree that the following Fee Schedule shall supersede the existing Fee Schedule in Exhibit B of the Agreement:


