# **CONTRACT PROCEDURES:**

- 1) FPOs SHALL NOT be used to order services from this contract.
- **2)** Departments may issue a requisition for a Blanket Order or by the instance.

The CITY and the CONTRACTOR mutually agree Emergency response time compliance is a critical area and whereas failure to provide service within one (1) hour is a detriment to CITY services. Therefore, the CONTRACTOR agrees to credit the CITY the full service call fee in the event the CONTRACTOR fails to arrive on-site at the required location within one (1) hour of the telephone call. The CITY reserves the right to cancel this AGREEMENT in its entirety should the CONTRACTOR fail to meet the Emergency response time five (5) times within any six (6) month period.

#### COMPLETE SCOPE OF SERVICES:

CONTRACTOR shall furnish required tires, materials and services as specified or indicated in the Agreement Documents, which shall include:

- Furnish and install Florida Sheriff's Association contract tires (Bridgestone/Firestone) on City vehicles;
- **Note:** Divisions may purchase tires from St of FL Contract vendor, Goodyear Tire. See Mat-Tires C2009101 for contract information.
- Road side emergency and non-emergency tire service;
- Scheduled tire service;
- Furnish and install recap tires, which shall include the pick-up of tire casings; and
- Inventory minimum tire requirements.
- Storage of the CITY's recapped tires and casings.
- Services to support the City during an emergency or disaster event. This shall require the Offeror to provide an outfitted service truck and mechanic with required parts and supplies to provide necessary tire repair over an extended time.
