Having carefully examined the "General Conditions", and the "Detailed Specifications", all of which are contained herein, the Undersigned proposes to furnish the following which meet these specifications:

Trim all of the palm trees including Sabal Palms, Royal Palms and Washingtonian Palms for Lee Tran from one to four times per year depending on the type of palm. Lee Tran personnel will decide how many times they will need to be trimmed.

All pruning shall be overseen and supervised by an ISA certified Arborist. Please include a copy of your Arborist's certification with your bid.

All trimming should be done per the most recent industry standards and best management practices making sure to not over trim or prune. Palm fronds, flowers and seeds should be removed.

All debris from the trimming and pruning needs to be properly removed.

You must proceed with caution when working near any of the pedestrian areas and make sure they are kept free from debris.

Please coordinate with Lee Tran personnel if you are going to be working around the Parking lots so no damage will occur to any of the vehicles.

Please remember that all debris must be removed immediately. If you neglect to remove the debris we will hire someone to remove for you and deduct it from your payment.

If you do not trim or prune the palms properly it could lead to your dismissal. No price increases will be allowed during the three year term.

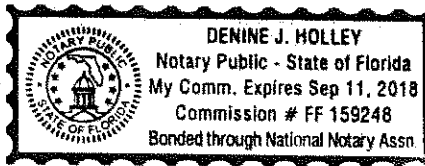
