# **ACTION REQUESTED:**

- A. Concur with the selection by the Proposal Selection Committee for RFP150216 LEE COUNTY VISITOR & CONVENTION BUREAU GERMANY, AUSTRIA, SWITZERLAND REPRESENTATION, and authorize staff to negotiate with the number one ranked firm Global Communication Experts GmbH, for a contract period of one year, with the option of three additional one-year periods. Commencing on October 1, 2015.
- B. Approve an anticipated annual expenditure of \$300,000.00
- C. Grant the Procurement Director, with County Administration approval, the authority to renew this agreement for three additional one-year periods, at the same terms and conditions, if doing so is in the best interest of Lee County.
- D. Authorize the Chair to execute the Agreement on behalf of the Board upon receipt.

Proposals were solicited on behalf of the Board of County Commissioners for the project known as RFP150216 VISITOR AND CONVETION BUREAU GERMANY, AUSTRIA, SWITZERLAND REPRESENTATION.

On the established deadline of May 5, 2015, Procurement received four (4) proposals. All Proposals were considered at the Proposal Evaluation Committee meeting on May 21, 2015. The Committee consisted of the following staff members: Pamela Johnson, VCB, Steffanie Zinke, VCB, and Carol Obermeier, Port Authority. Firms were evaluated on points-based criteria with a maximum score of 1000 points achievable. Based on the total points scored, Global Communication Experts GmbH was ranked Number 1 (scoring 960 points), Aviareps Toursim GmbH was ranked Number 2 (scoring 830 points), and TravelMarkeing Romberg TMR GmbH was ranked Number 3 (scoring 803 points). Our recommendation is to award to our Number 1 ranked firm Global Communication Experts GmbH.
