TITLE: Award Contract for United Kingdom, Ireland, and Scandinavia Representation

#### I. MOTION REQUESTED

A.) Award Request for Proposal No. RFP210186DWJ VCB United Kingdom, Ireland, and Scandinavia Representation to Four Communications Ltd. for professional tourism representation for Lee County, on an as needed basis, for an initial term of three years as approved in the departments' annual adopted budget.

- B.) Authorize the Chair to execute the contract documents on behalf of the Board of County Commissioners.
- C.) Grant the County Manager or designee the authority to renew the contract, for up to 3 additional years, and to execute all associated documents, as approved in the departments' annual adopted budgets, if doing so is in the best interest of Lee County, and there are no cost increases associated with the renewal.

#### II. ITEM SUMMARY

Approves a three-year contract for professional tourism representation for Lee County with the incumbent vendor, Four Communications Ltd., in the total amount of up to \$900,000 (\$300,000/year). Actual yearly expenditures will be included and approved in the department's annual adopted budget.

#### III. BACKGROUND AND IMPLICATIONS OF ACTION

### A) Board Action and Other History

Four Communications Ltd. is the incumbent vendor currently providing Lee County tourism promotion in the United Kingdom, Ireland, and Scandinavia under Solicitation No. RFP170282LAC adopted by the Board on December 5, 2017 which expires on September 30, 2021 after a 9 month extension.

Lee County Visitors & Convention Bureau submitted a request to Procurement Management to obtain proposals on behalf of the Board of County Commissioners for the project known as RFP210186DWJ, Lee County Visitor & Convention Bureau United Kingdom, Ireland, and Scandinavia Representation.

On the established proposal deadline of April 29, 2021, Procurement received six proposals. An evaluation meeting was held on June 3, 2021 during which the Evaluation Committee considered criterion as listed in the solicitation request including such items as Tourism Industry Experience, Similar Work Experience, Firm Plan of Approach, Personnel/Resources, Support Office Location, and Detailed Proposal. On the basis of the information submitted by the firms in their proposals, it was the consensus of the Committee to recommend to the Board the ranking as follows: 1) Four Communications Ltd. 2) Gosh PR Limited and Ignite Sales & Marketing Ltd. 3) Hills Belfour Ltd.
