### I. MOTION REQUESTED

A) Award Request for Proposal No. RFP170241DLK Wastewater Collection System to Miller Pipeline, LLC for wastewater collection system rehabilitation on an as needed basis for a period of two years as approved in the department's annual adopted budget.
B) Authorize the Chair to execute the contract documents on behalf of the Board of County Commissioners.
C) Grant the Director of Procurement Management the authority to negotiate renewals of the contract, including changes in price, and to execute renewal documents for up to three additional one-year periods, with County Administration approval, as approved in the department's annual adopted budget, if doing so is in the best interest of Lee County.

#### II. ITEM SUMMARY

Awards Request for Proposal No. RFP170241DLK Wastewater Collection System to Miller Pipeline, LLC for wastewater collection system rehabilitation on an as needed basis for an initial contract period of two years, with up to three additional one-year renewal periods. Expenditures for these services totaled approximately \$635,807 during Fiscal Year 2016-2017.

## III. BACKGROUND AND IMPLICATIONS OF ACTION

#### A) Board Action and Other History

The Utilities Department submitted a request to Procurement Management to obtain proposals for the project known as RFP170241DLK, Wastewater Collection System.

On the proposal deadline of August 22, 2017, the Procurement Management Department received one proposal. The proposal was evaluated on October 11, 2017, the Evaluation Committee by super majority vote, elected to accept the proposal from Miller Pipeline, LLC.

Expenditures for these services totaled approximately \$635,807 during Fiscal Year 2016-2017.
