On April 2, 2013 the Division of Procurement Management received three sealed bids for the Yard Waste Grinding and Processing Services. Step One involved evaluation of the vendor qualifications by the Review Committee. As a result of the review the Committee determined all three vendors: Tag Grinding Services, Inc., Barry Recycling, Inc. and Belcorp/Prolime Joint Venture LLC, were qualified and should proceed to Step Two (bid opening). On April 11, 2013 as part of Step Two, the bids were opened. The low bidder was Belcorp/Prolime Joint Venture LLC and the Committee recommends awarding a contract to the low bidder.
