## FIRST AMENDMENT OF THE AGREEMENT FOR YARD WASTE PROCESSING, GRINDING AND MARKETING

THIS FIRST AMENDMENT OF THE AGREEMENT FOR YARD WASTE PROCESSING, GRINDING AND MARKETING, made and entered into by and between the Lee County Board of County Commissioners, a political subdivision of the State of Florida ("County") and Wherry Truck Lines, Inc. ("Vendor"), collectively, the "Parties."

WHEREAS, the County entered into an Agreement for the purchase of yard waste processing, grinding and marketing services through Solicitation No. B180204BAW with Vendor on the 14<sup>th</sup> day of November 2018 ("Agreement"); and,

WHEREAS, the Parties mutually agree to increase the price for the yard waste processing, grinding and marketing services; and,

WHEREAS, the Parties mutually agree that the price increase will begin on the 24<sup>th</sup> day of October, 2022; and,

WHEREAS, the Parties desire to modify the Agreement pursuant to Article XV. MISCELLANEOUS of the Agreement.

NOW, THEREFORE, IN CONSIDERATION OF THE FOREGOING AND THE MUTUAL COVENANTS CONTAINED HEREIN, IT IS AGREED AS FOLLOWS:

- 1. The Parties agree that the price increase will begin on the 24th day of October, 2022.
- 2. The Parties agree that the following Fee Schedule table shall supersede the existing Fee Schedule table in Exhibit B of the Agreement:
