The meeting will be held at the Old Courthouse, 2120 Main St., Fort Myers. The budget hearing begins at 5:05 p.m.**

**If approved, the declaration would enable the county to continue and further its response efforts to Hurricane Irma. This is a typical step counties impacted by hurricanes take and is consistent with the Board's action post Hurricane Charley.**
