

Florida Statute

- Requires County Membership
- §186.504, 1973

Florida Administrative Code

- Each County 2 Seats
- AC291-1, 1976
- Each Municipality 1 Collective Seat per County
- AC291-1.04, 1988

Interlocal Agreement

- Dues Set at 30 Cents Per Capita (1973)
- Allows Counties to give 12-month notice to withdraw

❖ Sarasota County

- Notified RPC Withdrawing from Interlocal Agreement (Resolution 2017-002, adopted January 10, 2017)
- Will remain nominal member according to Florida Statute
- Will not pay assessment (\$116,142) or attend meetings






The Attorney General of Florida is an automatic member of CRC

CRC Amendments & Voting Results

1978 8 Proposals: All Rejected by Voters

1998 9 Proposals: 8 Passed, 1 Rejected by Voters

74.3%	Conservation: Natural Resources, Creates Fish & Wildlife Conservation Commission
72%	Firearms Purchase: Criminal Background Check Required & Waiting Period for Sales
71%	Education: Declared Paramount Duty of State to Provide Education for Children

66.3%	Basic Rights : Explicitly Recognizes Equality of Men & Women, Adds 'National Origin to Discrimination Protection, Renames to 'Physical Disability'
