The interview/presentations were held on March 18, 2002. On the basis of the information submitted by the Contractors in their Qualification Statements, and after conducting the interview/presentations with the "short-list" Contractors, the Committee agreed to recommend award to Casey Construction. A letter was received from Casey Construction on March 19, 2002, indicating a fee of seven percent (7%) of the total cost of the project. It is estimated that the cost of the Lee County Constitutional Complex will be in the range of \$1,200,000.00, including a contingency allowance and anticipated general conditions costs. A Guaranteed Maximum Price (GMP) will be brought back for Board approval. Casey Construction will be required to enter into the Construction Manager Agreement.
