WHEREAS, the Florida Interlocal Cooperation Act of 1969, F.S.

163.01, was promulgated to permit local governmental units to make the most efficient use of their power by enabling them to cooperate with other governmental units, thereby providing services and facilities in a manner and pursuant to forms of governmental organization that will accord best with geographic, economic, population and other factors influencing the needs and development of local communities; and

WHEREAS, the County and SCPFCD are desirous of entering into an agreement for he purposes of assigning State EMS Grant Money,

NOW, THEREFORE, IT IS AGREED AND UNDERSTOOD BY AND BETWEEN THE PARTIES HERETO AS FOLLOWS:

SECTION ONE.

The County will assign funds in the amount of \$4,130.00 to the SCPFCD for the purpose of expanding and improving emergency medical services in their area of operation.

SECTION TWO.

The SCPFCD agrees to expend the funds in accordance to the line item budget listed in Attachment A which is hereby incorporated by reference.

Failure of SCPFCD to use the funds for the purposes outlined shall result in a forfeiture of the funds utilized for purposes inconsistent with this agreement.
