

7. BACKGROUND:

On 6-19-2001, the Board of County Commissioners approved an open-ended exotic pest plant control contract with F.D.E.P. by which task assignments are to be added as needed. The first task assignment was for Six Mile Cypress Slough in the amount of \$60,000 and this is the second task assignment. The third task assignment was for Conservation 2020 -- site #107 in the amount of \$80,000 dated 01/08/02.

F.D.E.P. has grant money through the Bureau of Invasive Plant Management for exotic plant control. The City of Cape Coral has applied and received approval for \$17,759.37 in funding from F.D.E.P. for an exotic control project at Eco Park. Lee County's assistance in allowing the City to use our contract with F.D.E.P. and use our contractor will allow their project to be completed within the required time period.


