ACTION REQUESTED: Authorize the scheduling of a public hearing for Tuesday, September 10, 2002 at 10:00 o'clock, a.m., during the regular Board Meeting to discuss the use of funds related to the Local Law Enforcement Block Grant.

7. BACKGROUND: The Local Law Enforcement Block Grant is part of the Fiscal Year 1998 Omnibus Appropriations Act of the Federal Government. Lee County has applied for a direct award of \$212,609. with a required cash match of \$23,623.

An advisory board must be established to review the application and make non-binding recommendations on the use of the funds. On July 3, 1996 the Board of County Commissioners appointed the Coalition for a Drug Free Lee County to serve as the advisory board for the grant. The Coalition will meet on August 13th, 2002 to review the 2002 Application and issue its letter of recommendation. *rs*

At least one public hearing must be held regarding the proposed use of the funds prior to obligation.
