On October 11, 1995, the Board amended the mandatory Garbage Ordinance by approving Ordinance 95-19. Section 6.7a provides a specific mechanism for deferring solid waste assessment payments given that the residential property owners meet certain conditions. Included with Administrative Code AC-10-2 are provisions for Hardship Payment Deferrals. The purpose of a Hardship Payment Deferral is to allow a lien to be placed against the applicant's property until yearly garbage service fees can be made.
