1. REQUESTED MOTION:

ACTION REQUESTED: Request Board conduct a Public Hearing and approve a Resolution to establish the Solid Waste Collection and Disposal Program Special Assessments, rates and charges for tax year 2003 (FY 03-04); approve the proposed Resolution setting the annual special assessments and fees for the 2003 tax year, and direct the special assessments to be placed onto the Lee County tax bill for collection by the Lee County Tax Collector per Section 197.3632, Florida Statutes, for the 2003 tax year and each year thereafter by the terms of the Resolution.

WHY ACTION IS NECESSARY: Lee County Ordinances Nos. 00-20 and 95-20, both as amended, require that the annual Solid Waste Collection and Disposal Special Assessments, rates and fees be adopted on or before July 30th of each year. To meet this requirement, the Board is being requested to set the rates and charges, and direct the special assessments to be placed onto the Lee county tax bill for 2003 and each year thereafter by the terms of the Resolution.

WHAT ACTION ACCOMPLISHES: Complies with the requirements of Lee County Ordinance Nos. 00-20 and 95-20, both as amended, establishes the annual special assessments, rates and fees for the Mandatory Solid Waste Collection and Disposal Program, and directs the placement of the solid waste assessments onto the Lee County tax bill for collection by the Lee County Tax Collector per Section 197.3632, Florida Statutes, for the 2003 tax year.

Background, Continued

On December 23, 1997, the Board of County Commissioners adopted Lee County Resolution No. 97-12-23, expressing its intent to utilize the Uniform Method of Collection of Special Assessments by the Lee County Tax Collector pursuant to Section 197.3632, Florida Statutes.

With the Board of County Commissioners' authorization for the adoption of the County's Fiscal Year 2003-04 and tax year 2003 Mandatory Solid Waste Collection Program, it is now appropriate that the annual special assessments, rates and fees for the Solid Waste Collection and Disposal Program be established for the tax year 2003.
