. REQUESTED MOTION:

<u>ACTION REQUESTED</u>: Approve resolution to the West Coast Inland Navigation District (WCIND) requesting an additional \$80,000 for marine law enforcement. Approve budget resolution in the amount of \$80,000, and increase the W-marine law enforcement FY03 project amend the FY02/03 CIP accordingly. Increase existing WCIND marine law enforcement subgrant agreements with Lee County Sheriff's Office in the amount of \$40,000 and the Cape Coral Police Department in the amount of \$40,000.

WHY ACTION IS NECESSARY: Additional funds are available from WCIND subject to a resolution from the County. The Board must approve contract changes.

<u>WHAT ACTION ACCOMPLISHES</u>: Allows the County to receive an additional \$80,000 in grant funding from WCIND and allocates the funds to the Cape Coral Police Department and the Sheriff for marine enforcement.
