AMENDMENT TO LOCALLY FUNDED AGREEMENT BETWEEN THE STATE OF FLORIDA DEPARTMENT OF TRANSPORTATION AND LEE COUNTY FOR DESIGN OF US 41 FROM CORKSCREW ROAD TO SAN CARLOS BOULEVARD

This is an Amendment to Agreement ("Amendment") by and between the STATE OF FLORIDA DEPARTMENT OF TRANSPORTATION, hereinafter referred to as the "DEPARTMENT" and LEE COUNTY, FLORIDA, hereinafter referred to as the "COUNTY".

WITNESSETH

WHEREAS, the DEPARTMENT previously entered into an Agreement dated December 13, 2002 (the "Agreement") for the design phase of US 41 from Corkscrew Road to San Carlos Boulevard in Lee County under FM Number 195765-1-32-01, (the "PROJECT"); and

WHEREAS, the COUNTY and the DEPARTMENT desire to amend the Agreement according to the terms set forth in this Amendment; and

WHEREAS, except as set forth herein, all terms of the Agreement shall remain in full force and effect; and

WHEREAS, the COUNTY by Resolution No	_, dated the _	_ day of
, 2003, a copy of which is attached hereto and made a part her	eof, has author	rized the
Chairperson of the Board of County Commissioners to enter into this Amen	dment.	

NOW THEREFORE, in consideration of the mutual benefits to be derived from joint participation in the Agreement as amended herein, the parties agree to amend the Agreement as follows:

1. Paragraph 1 of the Agreement is deleted in its entirety and in its place shall be substituted the following:

The COUNTY agrees to advance funds to the DEPARTMENT for the total estimated cost of the design phase of US 41 from Corkscrew Road to San Carlos Boulevard (the PROJECT), in the amount of TWO MILLION TWO HUNDRED THIRTY-TWO THOUSAND SEVEN HUNDRED SIXTY-SEVEN AND 00/100 DOLLARS (\$2,232,767.00). The COUNTY has already deposited the amount of ONE MILLION SEVEN HUNDRED THOUSAND AND 00/100 DOLLARS (\$1,700,000.00). The COUNTY shall deposit the additional amount of FIVE HUNDRED THIRTY-TWO THOUSAND SEVEN HUNDRED SIXTY-SEVEN AND 00/100 DOLLARS (\$532,767.00).

This additional amount shall be deposited by the COUNTY, within fifteen (15) days of execution of this Agreement, in an interest bearing escrow account in the name of the Florida Department of Transportation with the Department of Financial Services and in accordance with the terms and conditions of the Memorandum of Agreement executed by the DEPARTMENT, the COUNTY and the Department of Insurance and by this reference made a part of this Agreement as though fully set forth herein. All references to the Florida Department of Insurance in the Memorandum of Agreement shall hereafter refer to the Florida Department of Financial Services. Interest from the account shall be left in the account to cover future deficiencies. All deposits shall be made to the Department of Financial Services and mailed to the Florida Department of Transportation for processing as follows:

Failure of the COUNTY to deposit said amount within the time frame specified above shall be grounds for termination of this Agreement.

2. The terms of this Amendment are hereby incorporated into the Agreement as if fully set forth therein. Except as expressly set forth in this Amendment, all other terms and conditions of the Agreement shall remain in full force and effect.
