**7. BACKGROUND:**  
An engineering study of the intersection of Bonita Beach Road and Bonita Grande Drive has determined that a traffic signal is the best solution to control traffic at this location. One approach of this intersection is private and not controlled or owned by Lee County, and lies within the boundaries of the City of Bonita Springs. As a result, the City was asked to assist in securing funds towards the installation costs of the proposed traffic signal. The City agreed and has collected funds from private parties in the amount of \$30,000. The estimated total cost of installation is about \$120,000.

Funds should be posted upon appropriation as follows:

 6039 - Bonita Grande Dr./Bonita Beach Rd.  
 30700 - Transportation Capital Improvement  
 506540 - Improvement Construction
