I am writing you today regarding the outstanding liens that have been placed on the aforementioned property. We are willing to reimburse the county for the hard cost that have been incurred, but would like to have the remaining balance waived.

Lee County Housing Development Corporation is a local non-profit agency that has been providing affordable housing to the residents of Lee County for over 12 years.
