On November 26, 2002 the BOCC approved the Second Amendment to the Interlocal Agreement with the City of Cape Coral for the East-West Corridor (Veterans Memorial Parkway). As part of the interlocal agreement, Lee County agreed to construct turn lane improvements at Burnt Store Road and Ceitus Parkway, utilizing surplus toll revenues generated from the Cape Coral and Midpoint Memorial Bridges.
