ACTION REQUESTED: Award B-03-16 *Demolition of Multiple Single Family Dwellings*, for the Department of Transportation, to the low bidder meeting all bidding requirements, Cross Environmental Services, Inc., for a lump sum amount of \$35,200.00 for Houses, and a lump sum amount of \$99,000.00 for Mobile Homes with a contract completion time of 150 calendar days.

WHAT ACTION ACCOMPLISHES: Demolition of multiple single family residential dwellings, both conventional built and mobile home type, and associated structures including sheds, septic tanks, underground piping, driveway culverts, driveway aprons, utilities, footings, slabs, spas and pools.
