The "Scope of Professional Services" as set forth in Exhibit "A" of the Professional Services Agreement, or Service Provider Agreement, referred to hereinbefore is hereby supplemented, changed or authorized, so that the CONSULTANT or SERVICE PROVIDER, shall provide and perform the following professional services, tasks, or work as a supplement to, change to, or authorized to, the scope of services previously agreed to and authorized:

I. INTENT

To provide design, construction plans and signalize the intersection of Bonita Grande Drive and Bonita Beach Road. The intersection improvements are to provide the following:

- Extend the eastbound to northbound left turn lane to make a 645' turn lane which includes the 50' taper.
- A 290' westbound to southbound left turn lane, which includes the 50' taper, use one thru lane and create a 290' (including a 50' taper) exclusive westbound to northbound right turn lane.
- Southbound lane configuration will consist of one shared thru and left 218' long (including the taper), and one 550' right turning lane including the 50' taper.
- Signalize the intersection.
- Interconnect to I-75 on the south side of Bonita Beach Road.
- Light the intersection and its approaches on the north, east and west side of the intersection.

II. SURVEY REQUIREMENTS

Provided by Pitman-Hartenstein & Associates, Inc. Engineers ("PH&A") under contract with the County. PH&A to provide design survey as follows:

- 1. Establish a baseline of survey with reference points and benchmark, and locate all above-ground improvements for the following:
 - Utilize the existing survey data for 800'± north of the Bonita Beach road center line along Bonita Grande Road.
 - Within the right-of-way and 25' beyond the Bonita Beach Road Right-of-way for 1000'+/-west, 1000'+/- east of the existing centerline of Bonita Grande Drive.
 - Within the right-of-way and 25' beyond the Bonita Grande Drive Right-of-way for 200'+/-south of the centerline of Bonita Beach Road.
- 2. Locate surface indicators of underground utilities existing within the defined project limits.

III. ELEMENTS PROVIDED BY THE CONSULTANT

The Consultant shall provide 60% and final plans preparation and assembly as outlined in the current Florida Department of Transportation Plans Preparation Manual and as required by the County including the following:

- 1. Perform the plans preparation and assembly to provide final plans and technical specifications for bidding purposes.
- 2. Separate technical specifications will not be required, as FDOT Standard Indexes and specifics will be referenced in the plans, as applicable. If site-specific characteristics dictate unique specs, then the consultant shall develop the specs.
- 3. Provide required corrections or additions to the plans brought about by the County quality assurance reviews.

- 4. Provide bid items and a quantity take-off of all quantities at 60% and Final Plans needed to bid and construct said project.
- 5. Coordinate improvements with the existing utilities and utility companies. Meet up to two times with the companies. If relocations are required, they will be designed by the individual utility companies. Plans to be provided to the utility companies at the 60% phase submittal. Final Plans are to be provided to the utility companies as well.
- 6. Traffic signal plans will be prepared for the intersection. The design will utilize strain poles.
- 7. Signal interconnection plans to I-75 will be prepared. The plans will be schematic due to the lack of survey for the corridor.
- 8. Lighting plans will consist of lighting the intersection and its approaches on the east, west, and north sides of the intersection. The lighting pole relocations if any will be coordinated with the County and power company.
- 9. Maintenance of Traffic plans are not part of this contract. The contractor is responsible for preparing a traffic control plan.
- 10. Evaluation of the intersection and adjacent roadways for resurfacing limits and sidewalk limits adjacent to the turn lane. All improvements to be confirmed with the County.
- 11. Provide cross sections at 100' intervals along the Bonita Beach Road and Bonita Grande Drive alignments.
- 12. Drainage design and analysis will consider effecting intersection and offsite areas. The design will determine detention/retention needs. The consultant is to pursue the appropriate SFWMD ERP permit. Environmental services will be provided by the County if required for permitting purposes.
- 13. Geotechnical services will only be utilized for the signal pole foundations. Other geotechnical services are not considered part of this contract. If analysis is needed one will be provided as an additional service. The pavement designs will be utilized from the Lee County LDC and the resurfacing will consist of replacing the milled depths.
- 14. Provide signing and marking plans for the intersection improvements.
- 15. Construction services to be provided as an additional service if requested.

IV. ELEMENTS TO BE PROVIDED BY THE COUNTY

In-house review of all elements of the plans at 60% and Final Plans stages. Responsible for furnishing traffic data if available to verify turn lane geometry. Assist in utility coordination as needed. Responsible for coordinating all permitting activities with Consultant and providing the permit application fees, as applicable.

V. PROVISIONS OF WORK

The Consultant shall furnish two (2) sets of 11"x17" size plans for all County reviews, to adequately control and coordinate the design approvals. Two (2) sets of 11"x 17"" plans shall be provided to the utility companies for coordination purposes. A list of Bid Items to be utilized will be provided and a copy of the computation booklet will be supplied for the final review. Consultant shall furnish two (2) complete sets of approved final plans (11"x17") and bid item list for bidding purposes. Project and design documentation will

be provided in written format as appropriate throughout the project.

VI. PLAN ASSEMBLY

The anticipated plan assembly consists of, and includes the following to be provided by the Consultant in the contract plans preparation:
