#### 1. REQUESTED MOTION:

<u>ACTION REQUESTED</u>: Accept contribution of \$1,476,660 from FGCU as per the Amended Campus Development Agreement. Also, accept \$889,000 from the City of Bonita Springs as per the approved Joint Supplemental Interlocal Agreement for Three Oaks South, and approve budget resolutions and amend FY03-07 Capital Improvement Program.

WHY ACTION IS NECESSARY: Requires BOCC approval for budget resolutions and amendments to CIP.

WHAT ACTION ACCOMPLISHES: Allows County to accept a contribution from FGCU and allows County to utilize \$670,773 for the Koreshan Blvd. Extension Project. Also, allows funds received from the City of Bonita Springs to be expended on the Three Oaks Extension, South project.

An amended Campus Development Agreement between Lee County and Florida Gulf Coast University was adopted March				

An amended Campus Development Agreement between Lee County and Florida Gulf Coast University was adopted March 19, 2003, which identified the expected impacts on County facilities and necessary mitigation for the university through 2010. The agreement required the payment of a total of \$1,476,660 as additional mitigation above previous payments, of which \$555,887 was to go to Lee Tran for mass transit impacts, \$250,000 was to go to the San Carlos Fire Protection and Rescue District, and \$670,773 was for mitigation of impacts on area roads. DOT staff is proposing that the additional transportation funds be applied to the nearest road project scheduled in the area around the university, the Koreshan Boulevard Extension (CIP Project #5021).
