- 1. ACTION REQUESTED/PURPOSE: Award and authorize staff to enter into a Construction Manager Agreement for RFQ-05-16 SIX MILE CYPRESS SLOUGH VISITOR CENTER, to Gates McVey Butz for the sum of six (6%) percent of the total construction cost of the project. This project was in the CIP and funds are available within the budget. Also request Board approve waiving of any formal process (if needed) and authorize the use of the Direct Material Purchase Orders as provided for in the CM agreement with Lee County, which allows the County to purchase directly from suppliers of equipment and/or materials as a cost/time saving measures.
- 2. WHAT ACTION ACCOMPLISHES: Provide construction management services for construction of a visitor center located at Six Mile Slough Preserve, 7751 Penzance Blvd., Fort Myers, FL. Facilities include an approximately 6,000 s.f. building, to be constructed in compliance with "LEED Green Building" certification requirements.

9. Background:

Letters of Qualifications were solicited on behalf of the Board of County Commissioners for professional construction management Services, for the Six Mile Cypress Slough Visitor Center project.

The deadline for receipt of the Qualification Submittals was October 18, 2005. A total of four (4) submittals were received by the established deadline date. All four (4) submittals were considered at the Qualification Selection Committee meeting held on October 27, 2005. The Qualification Selection Committee consisted of the following staff members: Jim Lavender, Director of Public Works, as Chairman, Bob Taylor, Construction & Design as Project Manager, and John Yarbrough, Director Parks & Recreation. Based on the information submitted by the Contractors in their Qualification Statements, it was the consensus of the Committee to invite the three (3) firms for interviews/presentations.

After conducting the interviews/presentations with the three "shortlisted" firms on November 10, 2005. It was the consensus of the Committee to recommend award the following Contractor ranking: (1) Gates McVey Butz; (2) J.L. Wallace Inc., and (3) Stultz, Inc.

A letter was received from Gates McVey Butz on December 16, 2005, indicating a construction management fee of six (6%) percent of the total construction cost of the project. A Guarantee Maximum Price (GMP) will be brought back for Board approval.

Gates McVey Butz will be required to enter into the Construction Manager Agreement and provide the necessary Public Payment and Performance Bond and certificate of insurance.


