## 765-650-175 23 FOOT BOOM MOWER AND TRACTOR COMBINATION

## INTENDED USE

USED FOR CUTTING GRASS AND BRUSH ON ROADSIDES, AND OTHER AREAS THAT IS NOT ACCESSIBLE WITH CONVENTIONAL MOWING EQUIPMENT.

CUTTING HEAD: Steel mower deck fabricated for heavy-duty service. Hydraulic motor connected to main drive shaft of the cutter. Minimum two, free swinging, heat treated, cutting blades. Full length replaceable skid shoes. Discharge area must be shielded to protect against thrown debris.
