9. Background:

The Board of County Commissioners created the Cherry/Blueberry Lane Special Improvement MSBU on April 3, 1996, when it adopted Resolution Nos. 96-04-160 and 96-04-161. The principal purpose of the project is maintenance of the currently existing roadways and street lighting for Cherry and Blueberry Lanes in St. James City, the cost of which will be assessed proportionately against benefited property owners. A requirement for maintenance to be accepted by the County is to obtain Quit-Claim deeds from all benefited property owners.

This is the last remaining property for which a deed conveyance to the County is required.
