#### 9. Background:

The Lee County Housing Development Corporation is requesting:

- 1) <u>Eliminating the provision of building a house for a very low-income household</u>. Under the current economic conditions, the agency has not been able to qualify a very low-income household for the purchase of one of their homes.
- 2) Adding a provision of building a house for a moderate-income household. A household that qualified to purchase a house as a low-income household lost that qualification when the head of household was hired to be a teacher for the Lee County School District. Since the household's income increased after the application was filed and while it was being processed, the agency is requesting this amendment in order to allow this particular household to still buy a LCHDC home.

#### Proposed Amendment

• Contract C-3072 - revise the scope of work as follows: Construction of 4 single-family homes for 1 very low and 3 low-income and 1 moderate-income households.

Staff recommends approval and finds that: it is in compliance with the SHIP rules and regulations; will ensure a timely completion of this project; and, fulfill the terms of the grant award agreements. No additional SHIP dollars are required.
