9. Background: In accordance with Lee County Ordinance 04-18, the Enhanced 9-1-1 Telephone System Program Manager shall recommend approval for street name changes of existing plats within the unincorporated areas of Lee County. The reason for this action is an effort by the County and the City of Bonita Springs to rename an existing roadway to an appropriate street type, up to East Terry St. as it will be redesigned in future construction.

Intended reconstruction will realign a portion of Imperial St and extend it north to connect to Coconut Rd and Three Oaks Pkwy. This extension will make a corridor from north Naples into Lee County that will extend up to Alico Rd. There are 27 property owners that will be affected by this change. Fifteen with home sites and 11 business sites.
